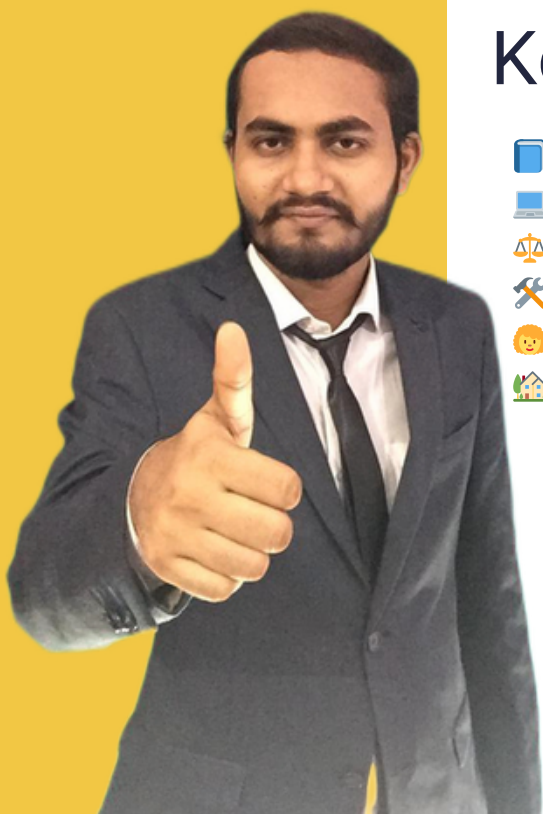
Our Mission

To build an aware, educated, and self-reliant society where every youth becomes a catalyst for positive social transformation.

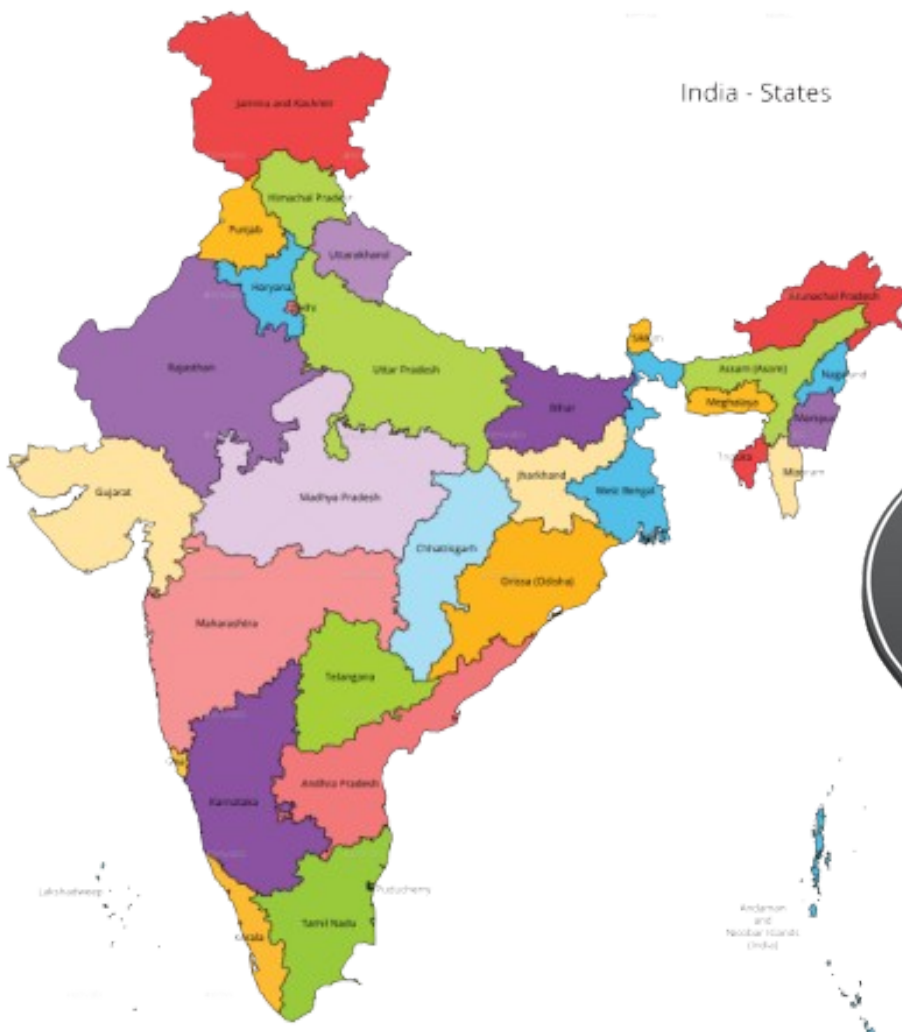

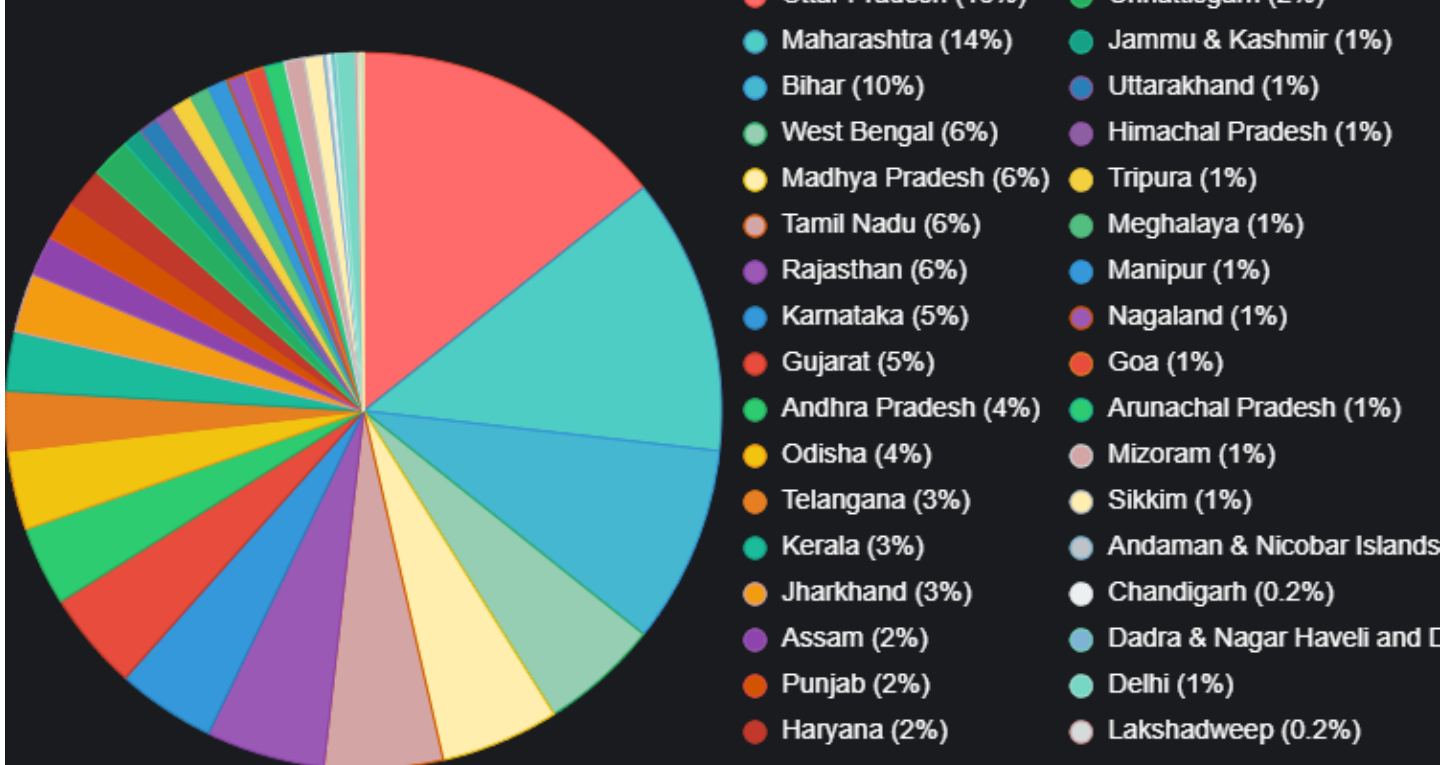

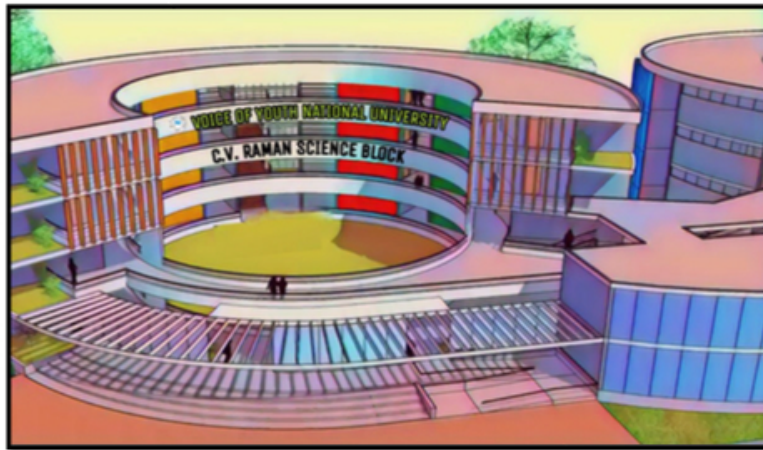
